Out of respect for your privacy, SADD (Students Against Destructive Decisions) provides this information explaining our online information practices. This policy does not apply to individual SADD chapters or state organization websites.

SADD was founded in 1981 as Students Against Driving Drunk and currently sponsors chapters called Students Against Destructive Decisions. Our mission, simply stated, is to provide students with the best prevention tools possible to deal with the issues of underage drinking, other drug use, risky and impaired driving, and other destructive decisions.

Information We Collect & How We Use It

For each visitor to our web page, our web server automatically recognizes only the consumer's domain name but not the email address (where possible).

We collect information volunteered by the visitor, such as survey information, chapter registrations, programming requests, and mailing list signups.

The information we collect is used to provide information and services to registrants according to their requests and to conduct the business of the organization. SADD will not sell your information to other businesses or organizations.

We make available our chapter registration information to SADD state coordinators in the states of registration and to agents of the organization necessary to perform our business. We will perform mailings or other communications to our chapter and mailing lists upon request of select government, corporate, and nonprofit partners in

circumstances that advance the mission of the organization. We do not sell any of the names, email addresses, or other information that we collect.

A Note about Donor Information

We maintain records of all financial contributions made to SADD. Personal information is private and confidential. SADD may contact donors with further communications via the web, US Postal Mail, or telephone. When individuals make a donation online, we may request the following:

- First and last name, street address, city, state, zip code, telephone number, email address, and clarification of gift type, e.g. memorial or honorary contributions.
- Through PayPal, standard credit card information (card number, card type, expiration date) is processed in a secure, encrypted session, a proven standard for secure web messaging transactions.
- In the case of memorial or honorary contributions, a personalized tribute letter is sent to a designated recipient, usually the family member of the deceased or the individual for whom the tribute is made. The gift amount is withheld. Therefore, we will request the name, address, city, state, and zip code for your designated tribute letter recipient.

Aggregate Information Collected from the Web Server

We collect anonymous information from our web server about your visit to our site in order to monitor general traffic patterns on our site. This information is collected and stored in paper files, and benchmark data is maintained on an electronic file on the server. We compile and analyze this information using Traffic Facts software. Reports generated by Traffic Facts include information such as the following.

- total number of visitors
- most visited pages
- peak traffic time
- browser versions
- search terms used
- average number of pages requested
- average duration of visit
- total visitor traffic

A Note about Cookies and Ad Servers

With respect to cookies, we do not require cookies to be set by the user.

With respect to ad servers, we do not partner with nor do we have special relationships with any ad server companies.

Data Security

To prevent unauthorized access, maintain data accuracy, and ensure the correct use of information, we strive to maintain physical, electronic, and administrative safeguards to secure the information we collect online. This includes the use of PayPal for processing financial donations securely.

SADD is not responsible for the contents of any linked website. The inclusion of any link does not imply endorsement by SADD of that website and is provided only for informational purposes.

SADD reserves the right to change this policy at any time. Our privacy policy will be kept up-to-date and clearly posted on our website.

From time to time, we may use registrant information for new, unanticipated uses not previously disclosed in our privacy notice. If our information practices change at some time in the future, we will post the policy changes to our website and provide website visitors with the ability to opt out of these new uses. If website visitors are concerned about how information is used, he/she should check back at our website periodically. Registrants may prevent their information from being used for purposes other than those for which it was originally collected by sending us an email at the address provided above.
